PLEASE REVIEW AUGUST Board of Directors MEETING MINUTES ON PAGES 4, 5, 6 & 7 for approval

The first Board of Directors meeting took place on July 16, 2014 at Melissa Guidry's house. Melissa, President, called the meeting to order at 7 pm. Brenda Falanga, Mary Anne Toledano, Darlene Russo, Ann Burghardt-Deick, Frances Hughes and Linda Levesque. Carrie Thomson joined the group later.

Old Business: The chapter needs more fund raisers. Selling calendars was discussed at previous meetings. It was decided that calendars would not a good fund raiser because they would have to be sold for \$15.00 in order to make a profit. Frances suggested 50/50 like at the meetings, but on a larger scale. Baton Rouge sells t-shirts associated with Susan G. Komen. The t-shirts are pre ordered and delivered. TRIVIA CORNER FROM THE

What is the recommended relative humidity range in a restricted area?

The relative humidity in a restricted area should be maintained within a range of 20% to 60%.

When should hair at the surgical site be removed?

If the presence of hair will interfere with the surgical procedure and removal is in the best interest of the patient, the following precautions should be taken:

- Hair removal should be performed the day of the surgery, in a location outside the operating or procedure room.
- Only hair interfering with the surgical procedure should be removed.
- Hair should be clipped using a single-use electric or battery-operated clipper, or clipper with a reusable head that can be disinfected between patients

Where should the chemical indicators be placed in instrument sets for sterilization?

Chemical indicators (CI) should be placed in an area within the package that presents a challenge for air removal and sterilant contact. When there is a question concerning the appropriate number and placement of internal CIs, the CI manufacturer, the device manufacturer, and the containment device manufacturer should be consulted for additional information.

The number and placement of internal CIs may be affected by the contents of the package, the configuration of the items within the set, and the packaging or containment device.

By Laws Chair: Nathalie Walker discussed Chapter By laws and Policies related to Chapter Delegates. The following changes are proposed and will be open for discussion at the Sept 22, 2014 chapter meeting.

Current Bylaw: No proposed change ARTICLE VIII <u>Chapter Delegates</u>

A. Eligibility

- Delegates to the annual AORN Surgical Conference and Expo must have current membership status in the Chapter 1902 to receive funds from the chapter.
- 2. Representation
 - a. The delegate count is allocated annually to chapters by National based upon the ratio of total chapter membership as of June 30, with

- each chapter having a minimum of one (1) delegate.
- AORN of New Orleans may choose to seat delegates from another chapter to fill open delegate slots, if needed.

Current Policy with proposed changes in red DELEGATE POLICY

Delegates shall represent the local Chapter at the annual AORN Surgical Conference and Expo. The Chapter is entitled to elect at least one delegate based on total active membership. Total delegate numbers are determined by AORN, Inc, annually.

Election of Delegates - Eligibility

- A delegate must be a current voting member of AORN. Delegates are chosen on a point system.
- 2. A delegate should have attended at least six (6) general meetings the previous year, based on ten (10) meetings a year.
- 3. A delegate must have active participation on a local AORN committee the previous year.
- 4. The President and President-elect are automatically delegates and the President-elect shall act as Chairman of Delegates. All other eligible members that wish to serve as a delegate must fill out a "Willingness to Serve" form on or by the October meeting (form to be published in the September and October newsletter).
- The number of eligible members' persons receiving the highest number of points will be selected as delegates by the AORN of New Orleans Board.
- 6. Eligibility requirements may be waived in lieu of insufficient candidates.

Provisions for Delegates

- Delegates are required to <u>fulfill all delegate</u> <u>duties</u> <u>during at the Congress at the AORN's Surgical Conference and Expo. This includes but is not limited to all scheduled Forums and House of Delegate meeting held during the annual Congress meeting.
 </u>
- 2. Chapter Delegate funding is determined annually based on chapter resources.

BoD Meeting Minutes Continued:

Acceptance of funds by chapter delegate is based on the premises that they attend **All** the mandatory delegate activities during Congress. Failure to do so will result in the delegate returning a prorated portion of their funding **back** to the Chapter.

GUIDELINES FOR DELEGATE SELECTION

- Chapter membership for a pre-determined time (one year) before AORN Surgical Conference and Expo.
- 2. Attendance at a given number of monthly meetings/activities for the year preceding **(6)**.
- 3. Active participation in Chapter affairs, service on a committee, program participant, etc., for a year previous to selection.
- 4. The President and President-Elect are automatically delegates.
- 5. Assignments as a delegate may be an incentive award for a member other than an officer, if that person has contributed greatly to the functioning of the Chapter.
- 6. The amount of money that is available from the treasury will determine how the Chapter funds its delegates. Funds are distributed by the Treasurer prior to AORN Surgical Conference and Expo.
- 7. Delegates are required to fulfill all duties at AORN Surgical Conference and Expo. Failure to do so will result in the delegate returning a prorated portion of their funding to the Chapter. This amount is determined based on the number of mandatory delegate activities.
- 8. Any delegate/(s) failing to fulfill obligation in regard to voting and attendance at meetings may not serve as delegate for one year.
- AORN, Inc (Headquarters) recommends points system as the only fair way to choose delegates. Our point system is based annually (September 1 to August 31) on:
- 10. Member is responsible to turn in their points on an **AORN of New Orleans Chapter**
