NEWS ALERT:

U.S. Supreme Court upholds Affordable Care Act 6-3

The United States Supreme Court issued its much-awaited opinion in King v. Burwell. Chief Justice John Roberts wrote the opinion confirming that people qualify for federal subsidies whether they buy their health insurance through state insurance exchanges or the federal insurance exchange at HealthCare.gov. In affirming this key element of the Affordable Care Act, Chief Justice Roberts was joined by Justices Kennedy, Ginsberg, Breyer, Sotomayor and Kagan, while Justices Scalia, Alito and Thomas dissented. The opinion all but guarantees that the health care reform initiatives and insurance structures established by the Affordable Care Act will remain in place after President Obama leaves office in 2017.

HOW OFTEN SHOULD STETHOSCOPES BE CLEANED?

Stethoscopes should be cleaned with a low-level disinfectant before and after each use.

Stethoscopes are one of the most commonly and frequently used medical devices in a health care facility, and should not be worn around the neck. Stethoscopes come in direct contact with patients' skin, providing an opportunity for transmission of microbes from patient to patient, from patient to health care worker, or from health care worker to patient.

WHY SHOULD RINGS NOT BE WORN IN THE PERIOPERATIVE ENVIRONMENT?

Studies have shown that wearing rings may result in colonization of the hands with pathogens such as gram-negative and gram-positive pathogens.

With an increasing number of rings worn, the pathogens recovered may also increase in number. In one study, isolates recovered from swabbing the area adjacent to the ring included coagulase-negative staphylococci, other skin flora, gram-negative cocci, *Pseudomonas spp, and Staphylococcus aureus.*

There is a strong link between wearing rings and contamination of hands by health care personnel; removing rings will decrease the potential for pathogens remaining on hands before and after hand hygiene.

Dr. Norman McSwain

As the new University Medical Center celebrates opening its expansive doors to the city of New Orleans, the medical community paradoxically mourns the passing of Dr. Norman McSwain, a pioneering leader of "The Spirit of Charity "in the city. The leadership of UMC released the following statement:

"Dr. McSwain joined the academic and clinical faculty at Tulane in 1977, but his main interest was in Charity Hospital and pre-hospital patient care – he came to New Orleans because he considered Charity Hospital to be one of the three most important trauma centers in the United States. Dr. McSwain was soon recruited by the City of New Orleans to develop an EMS system for the city, initiating both the EMT-Basic and EMT-Paramedic training within the New Orleans Police Department, and a Citywide EMS System.

During this time he was recruited to the American College of Surgeons Committee on Trauma to assist in the development of the Advanced Trauma Life Support program. To fill the gap in the trauma team he worked with the ACS/COT and the National Association of EMTs to develop the Pre-Hospital Trauma Life Support program. Today, PHTLS has trained over half a million people in 45 countries. It is considered to be the world standard for pre-hospital trauma care. He has worked with the military and the Department of Defense to develop the Tactical Combat Casualty Care program for military medics.

Dr. McSwain is the only person in the history of the American College of Surgeons to receive all five of the major trauma awards:

- Committee on Trauma, Meritorious Achievement Award for State/Provincial Chairs, 2001
- Scudder Orator, 2001
- Committee on Trauma Millennium Commitment Award, 2000
- Surgeon's Award for Service to Safety, National Safety Council, 1998
- Advanced Trauma Life Support (ATLS) Meritorious Service Award, Committee on Trauma, 1989
 Dr. McSwain also worked for over a decade to establish the Louisiana Emergency Response
 Network (LERN) in 2004, serving on LERN's board of directors since that time, including service as board chair from 2012 to 2014.

For over 30 years, Dr. McSwain provided care to severely injured police officers at Charity Hospital. While at Tulane, he wrote or revised more than 25 textbooks, published more than 360 articles and traveled throughout the world giving more than 800 presentations. He lectured in all of the 50 states, all provinces in Canada, most of the countries in Europe, most of the countries in Central America, and the upper part of South America., as well as in Japan, China, Australia, and New Zealand."
